3. In case of night halt of the escort unit you have to provide lodging and boarding facilities to the unit.
4. For the PSO the client should provide barrack facilities in the site.
5. Any duties above 8hr you have to provide free fooding.
6. Payment shall be made within 7 days from the submission of the invoice. If payment will not be released within the month end then the duty will stop from first of next month.
